Vehicle Information: Each vehicle must submit separate, completed entry form. Forms and accompanying photos may be mailed to: Jack Dietz, 180 Knoll Rd., Yakima, WA 98908

If you submit more than one vehicle, you may make one inclusive payment for all entries, but a separate, completed entry and photos must be submitted for each vehicle. Group application does not guarantee acceptance of all entries.

Photos: Two high quality photos of your vehicle should be submitted with your application. At least one should be a ¾ front view, with the hood, doors and truck lid closed. These photos will be used to select vehicles for the show and may be used in promotional and printed media. The Vintiques of Yakima reserves the right to use these photos before and after the show. Photos will not be returned.

Space: Exhibit space is 10' x 20'. Electrical hookups are available through the Sundome at an extra cost.

Accepted Entries: A letter accepting your entry will be mailed to the address on your application.

Present the letter at the Registration area of the Sundome for your entry packet and credentials. No vehicle substitutions will be accepted for the indoor show without prior arrangements.

Entry protocol: Vehicles with more than ¼ tank of fuel will be denied entry. All vehicle fuel tanks will be checked. Spaces will be assigned by Vintiques and placement is final.

Move in and set-up: Present your acceptance letter at the Registration area of the Sundome on Thursday, August 1 as early as 8 am but not later than 7 pm. All entries must be set up and ready for judging at 9 am on Friday, August 1.

Exit: Vehicles **cannot be moved** prior to 6:30 pm Saturday. All vehicles and displays must be out of the Sundome by 9 pm Saturday. Entrants are welcome to participate in outdoor activities after exiting the Sundome but must adhere to all participant expectations and limitations and display window sticker, individual entry credentials, and wristband which must be worn at all times.

Awards: CASH PRIZES!\$!\$ for indoor show will be awarded Saturday at 4 pm in the Sundome.

Overall event awards presentation begins at 10 am Sunday, August 3.

The exhibitor hereby applies to the Vintiques of Yakima to have the vehicle described above displayed therein and agrees that, if the application is accepted, vehicle will be displayed under the following terms and conditions:

In such case where entry is denied or not accepted, monies will be refunded.

As between the exhibitor and the Vintiques, the Vintiques shall have the final authority to determine the location of an exhibitor's display within the show, and the exhibitor's compliance with the aforesaid rules, regulations and policies.

Once the exhibitor's display and/or vehicle are set up in the show, they shall not be moved, removed or concealed by the exhibitor prior to the end of the show without the permission of the manager/producer. Any violators of this rule will be removed from the judging

Neither the producer, a sponsor, nor any officer, director or shareholder thereof or the owner of the building at which the show is produced, shall be responsible or liable for any loss or damage to all or any part of the exhibitor's personal property, which shall specifically include, but is not limited to, the exhibitor's vehicle, trailer, display material and/or parts, and the exhibitor hereby waives any and all rights it may have against them or any of them for such loss or damage. Exhibitor agrees to obtain insurance covering the above and assumes full responsibility of any loss or damage. Exhibitor agrees that this signed entry form supersedes any and all prior agreements and understandings whether written or oral between the exhibitor and producer, its committee, show staff, representatives and sub-contractors.

No commercial advertising is allowed with entries unless they are appearing in conjunction with paid commercial space. A single sign may be used to identify major modifications, identifying who did them and what equipment was used. Ad signs, handbills or business card distribution is prohibited.
